### Office of Information Technology

#### **Information Technology (IT) Specialist (Information Security) GS-2210-09/11/12/13/14**

IT Specialists (Information Security) perform work that involves ensuring the confidentiality, integrity, and availability of systems, networks, and data through the planning, analysis, development, implementation, maintenance, and enhancement of information systems security programs, policies, procedures, and tools. Specific duties and responsibilities include, but are not limited to, reviewing proposed new systems, networks, and software designs for potential security risks; identifying the need for changes based on new security technologies or threats; and developing long-range plans for IT security systems that anticipate, identify, evaluate, mitigate, and minimize risks associated with IT systems vulnerabilities.

#### **Information Technology (IT) Specialist (Policy and Planning) GS-2210-09/11/12/13/14**

IT Specialists (Policy and Planning) develop, implement, and ensure compliance with plans, policies, standards, infrastructures, and architectures that establish the framework for the management of all IT programs. They perform a wide range of duties that can include strategic planning, capital planning and investment control, workforce planning, policy and standards development, resource management, knowledge management, architecture and infrastructure planning and management.

#### **Information Technology (IT) Specialist (Applications Software) GS-2210-11/12/13/14**

IT Specialists (Applications Software) translate technical specifications into programming specifications; develop, customize, or acquire applications software programs; and test, debug, and maintain software programs. Specific duties include, but are not limited to, identifying and defining business or technical requirements applied to the design, development, implementation, management, and support of software systems, networks and data; evaluating proposals for the acquisition of software products; and evaluating the impact of technological changes on application software within the Department of Homeland Security.

#### **Information Technology (IT) Specialist (Customer Support) GS-2210-11/12/13**

IT Specialists (Customer Support) provide technical support to customers who need advice, assistance, and training in applying hardware and software systems. Specific duties and responsibilities include, but are not limited to, diagnosing and resolving problems in response to customer reported incidents; installing, configuring, troubleshooting, and maintaining customer hardware and software; and researching, evaluating, and providing feedback on problematic trends and patterns in customer support requirements.

#### **Information Technology (IT) Specialist (Network) GS-2210-11/12/13**

IT Specialists (Network) test, install, configure, and maintain networks including hardware (servers, hubs, bridges, switches, and routers) and software that permit the sharing and transmission of information. Specific duties and responsibilities include, but are not limited to, planning, designing, developing, and integrating network systems consistent with existing or planned network infrastructures; conducting analysis of and recommending solutions to problems/issues involving the local computer network; and testing and optimizing the functionality of systems, networks, and data.

**Telecommunications Specialist GS-0391-11/12/13**

Telecommunications Specialists perform technical and analytical work pertaining to planning, developing, acquiring, testing, integrating, installing, utilizing, or modifying telecommunication systems, facilities, services, and procedures. Specific duties and responsibilities include, but are not limited to, preparing feasibility and suitability assessments on new or existing technology; carrying out all phases of installation, troubleshooting, repair, redesigning, and maintenance and operational testing of telecommunications systems; and configuring and maintaining the telecommunications network to service applicable law enforcement mission applications.

**Mission Support Specialist GS-0301-11/12**

Specific duties and responsibilities include, but are not limited to, applying a wide range of administrative program concepts, laws, policies, practices, and analytical/diagnostic methods and techniques to address issues or problems, developing and delivering briefings, project papers, status reports and correspondence to managers.

**Management and Program Analyst GS-0343-09/11/12/13/14**

**Sector Enforcement Specialist: GS-1801-09/11**

This position serves as a key member of professionals providing federal law enforcement support of ground, sea, and air operations. Specific duties and responsibilities include, but are not limited to, independently coordinating needed assistance and dispensing requested enforcement data in real-time, assisting in the design, development, and performance of operational tests that measure the effectiveness of network hardware/software under various contingencies, monitoring and operating network equipment for the performance of the first echelon duties and assisting in the development and implementation technologies, analyzing, evaluating, and monitoring identified or potential problem areas and providing recommendations regarding law enforcement activity and overall system performance and using report generators and other means to extract applicable data from national, regional, and local enforcement information systems
